Releasor declares that no promise, inducements nor agreements not herein expressed have been made to Releasor, and that this agreement contains the entire agreement between the hereto and the terms of this release agreement are contractual and not a mere recital.

Releasor represents that at the time of the execution of this release agreement that he/she is of legal age and is of sound mind.

It is expressly understood and agreed by Releasor that the above permission is, in fact, full and adequate consideration to be received as aforesaid from Releasee, and that Releasor will satisfy

any all subrogation demands, or expenses as might be asserted, if any, and in the event that any demand is made upon any of the parties released herein or their agents and/or representatives for additional payment that Releasor does hereby covenant and agree to indemnify and save harmless Releasee, its respective insurers, agents, officers, employees, and servants, and any and persons, firms or corporations, and each of them, from any and all claims and/or demands as might be asserted by such third parties.
